PPE DESCRIPTION:

The waistcoat is a loose-fitting, sleeveless garment made from fluorescent yellow woven fabric with reflective bands applied.

It is made from a single piece of fluorescent yellow woven fabric joined by a seam at each shoulder to form a waistcoat. The front opening closes by means of a black plastic zip with metal pull.

Two 5 cm-wide bands of reflective material in grey are applied around the upper body and two similar bands are applied vertically running over the shoulders from front to back.

The collar is pointed and a garment identification label is attached inside at the back of the seam between the collar and the back.

The garment is edged completely in fluorescent yellow edging tape.

The materials that form the PPE, are described in the test report n° 2014EP2356



It shall be the manufacturer's sole responsibility to furnish specific information pertaining to this certificate and the tested levels of protection.
